Q: What is the cost of the ASCO-SEP® Digital Subscription?

A: Pricing is as follows: ASCO Members: \$440; Non-members: \$550

Q: What is included in the Digital Subscription?

A: Your subscription to ASCO's Medical Oncology Self-Evaluation Program (ASCO-SEP®) gives you 12 months of access (from date of purchase) to 22 science- and evidence-based eBook chapters and 1400+ multiple-choice questions to assist in board exam preparation and to support clinical knowledge and skills development throughout your oncology career.

Q: What is unique about the 2025 Edition?

A: Each year the Digital Edition is updated to reflect current changes to clinical practice as well as to provide improvements to the user experience based on reader feedback and learning science. The 2025 Edition includes:

- 30+ Case Study discussions
- 22+ High-Yield Takeaways for board preparation focus
- Chapter Summary Guides
- eBook features such as bookmarks, notes, and highlighting
- Downloadable chapter PDFs for printing or saving
- Display options allowing the reader to customize fonts, layouts, easy-to-read page colors, scroll orientation, and screen brightness
- Updated search function for quick and comprehensive results

Q: Do I need to purchase Question Bank separately?

A: No, the ASCO-SEP® Question Bank is included in the ASCO-SEP® Digital Subscription.

Q: Can I obtain permission to reuse Question Bank questions or Digital Edition chapter content?

A: Please contact assessments@asco.org regarding reuse of ASCO-SEP® content.

Q: What activities are available in the Question Bank?

A: Users can combine **practice questions** into custom assessments of any length, on any topic(s), with no time limits. The **Timed Practice Exam** simulates testing over three hours with 100 curated questions aligned to medical oncology blueprints. Rationales and references are available for both activities.

Q: Why does the number of items in the Question Bank fluctuate?

A: Questions are routinely evaluated throughout the year based on a variety of factors including performance, recency, and relevance to medical oncology blueprints. Our subject matter experts review and update these questions as needed. In some cases, questions can be retired.

Q: Does ASCO-SEP® offer opportunities to claim CME credits or MOC points?

A: No, CME/MOC points are not offered for completion of SEP activities.

Trainee and Program Director–Specific Questions

Q: Are additional discounts available to trainees in international training programs?
